Announcements from HepTalk

Welcome to the (late) September/ (early) October 2005 edition of the Listserv. We're finishing a three part series on substance abuse and Hepatitis B and C. We began in July with information about substance abuse among migrant workers. In August, we offered information about "harm reduction" strategies for HCV substance abusers. In this edition, we offer information about substance abuse treatment for migrant and recent immigrant clients. The information sources in the September issue are the following:

1. Harvest House, a substance abuse facility with experience treating migrant clients
2. SAMHSA Facility Locator, an internet service that will help you locate substance abuse services with special language services near your clinic
3. Information from a HepTalk site which provides substance abuse counseling and Hepatitis C treatment at their clinic, and links to four related articles.

Substance Abuse Treatment for Migrants

Many clinicians have a difficult time locating referral sources for substance abuse treatment for their mobile and immigrant clients. Facilities that are both affordable and also have appropriate language services and cultural awareness are extremely difficult to find. Below is one such center we are aware of. We list it as an example of how to use the SAMHSA (Substance Abuse and Mental Health Services Administration) Substance Abuse Treatment Facility Locator <http://dasis3.samhsa.gov/Default.aspx>.

Because substance abuse treatment services are so hard to locate for low-income clients and Spanish-speaking clients, some clinics have taken it upon themselves to add these services in-house: one HepTalk clinic in Wisconsin has been able to offer these services through collaboration with The University of Wisconsin. You may be able to find ideas about funding sources they found to offer these services, and what you may be able offer on-site.

1. Harvest House

The Harvest House is a residential treatment program with experience in treating migrant clients. This facility works with Spanish-speaking clients from the Tri-County Community Health Clinic area, but they will also take referrals, and have worked with migrant clients from many other states, says staff member, Al Gonzales. "They do not have detox capability for patients other than those treated at the Tri-County Community Health Clinic".

2. SAMHSA Facility Locator

Here is an example of what information you would find if you used the facility locator to look up Harvest House in North Carolina:

Map It! (If you click here, the Locator provides a map which can be printed and given to the client)

- **Primary Focus:** Substance abuse treatment services
- **Services Provided:** Substance abuse treatment

- **Type of Care:** Residential short-term treatment (30 days or less), Outpatient, Partial hospitalization/day treatment
- **Special Programs/Groups:** DUI/DWI offenders
- **Forms of Payment Accepted:** Self payment
- **Payment Assistance:** Sliding fee scale (fee is based on income and other factors)
- **Special Language Services:** Spanish (These last three lines of information may be especially important in helping you determine if the facility listed is appropriate for your client.)
- **Intake:** (800) 567-5021 (Though the Harvest House does not have many facilities do, and you can access further information here.)

How to use the SAMHSA Facility Locator

Step 1: Go to <http://dasis3.samhsa.gov/Default.aspx>. On this page you will find a map of the United States.

To locate the drug and alcohol abuse treatment programs nearest you, find your State on the map below and click on it./

Step 2: To search for the drug and alcoholism treatment program, the Locator needs a starting point. A starting point can be a city, street and/or zip code. To find facilities nearest you enter your city, street or zip code.

NOTE: To protect your privacy, the information you entered will be permanently erased after your search is completed.

NOTE: to customize your search according to type of care and other facility services [CLICK HERE](#) or use the DETAILED SEARCH option shown on the left side of this page. This could reduce the number of facilities you have to consider.

PLEASE NOTE: While MCN has worked previously with Harvest House, and thus has knowledge of services and staff beyond the information that appears on the Locator, MCN cannot recommend Harvest House or any of the other sites listed there. The Locator and the sites

therein appear on this listserv to facilitate location of appropriate services for your clients by your staff, not as recommendations from MCN. 3. The Beloit Area Community Health Center

Through collaboration with the University of Wisconsin, which includes the use of Ryan White funding, is able to provide on-site Hepatitis C treatment and substance abuse counseling as part of their primary care service. An on-site nurse practitioner and a specialist from the University of Wisconsin see patients on a regular basis.
